SUCCESSION POLICY FOR THE BOARD OF DIRECTORS

PURPOSE: To ensure the proper structure of the Board of Directors of ISA, by establishing the profiles and requirements that are considered appropriate to perform the duties and responsibilities of a member of the Board of Directors and that allow for its effective operation and contribution to the achievement of organizational objectives
